L&T Wins ` 5689 Crore Contract for 2 x 660 MW Supercritical Power Plant in Rajasthan

First-of-its-NLQG (3& 2UGHU IURP 6WDWH 8WLOLW\ \$IILUPV Execution of Mega Power Projects

Mumbai, April 01, 2013 : L&T has secured an order valued at ` 5689 Crore from the Rajasthan Rajya Vidyut Utpadan Nigam Ltd for setting up a 2 x 660 MW Supercritical Thermal Power Project on a complete EPC ²Engineering Procurement & Construction ² basis.

The order involves design, engineering, manufac ture, supply, erection and commissioning of two coal -fired thermal units of 660 MW each with supercritical parameters at Chhabra in Baran District in Rajasthan.

The Rajasthan order comes as L&T enters the advanced execution phase of several large supercritical thermal power projects. These include complete projects being built on an EPC basis as well as boilerturbine -generator units and Balance -of -Plant packages. With this contract, L&T now has orders for supply and installation of 26 Supercritical Steam Generators and Steam Turbine Generators of 660 MW, 700 MW and 800MW.
